Position Summary: The Substance Abuse Counselor Instructor/Coordinator will be interested in and able to teach at a community college and baccalaureate level. The faculty member must be committed to working with a diverse range of student interests and abilities. The chosen candidate will engage in continuous institutional improvement efforts such as assessment, planning, and other related efforts. The faculty member will also coordinate with local agencies, cooperating counselors, and supervisors in assisting Substance Abuse Counselor candidates in fulfilling the field experience requirements for the Associate of Applied Science Degree and application for the Wisconsin Substance Abuse Counselor license.

Position Responsibilities & Duties:

- Monitor Substance Abuse Counselor Program curriculum and re-certification process with the State of Wisconsin.
- Collaborate with Directors of regional substance abuse programs for the placement of students to fulfill 360 hours of specialized education.
- Recruit Substance Abuse Counselor supervisors for students.
- Develop and implement procedures for supervision of field experience.
- Provide training for faculty and Substance Abuse Counselors in the supervision of students.
- Assist supervisors and counselors with students in the development of Pre-Professional development Plans.
- Assist students with application for Wisconsin Substance abuse Counselor Licenses.
- Teach assigned courses in Substance Abuse Counselor Program and related disciplines as appropriate.
- Development and implement Substance Abuse Counselor Program Curriculum as appropriate for a CMN student that transfers to four-year institutions.
- Utilize current technological tools in instruction.
- Assist in the development of strategies aimed at increasing student retention in Substance Abuse Counselor Program, researching and analyzing system solutions to administrative problems as they relate to student success.
- Participate in CMN committee, accreditation, and assessment processes.
- Participate in multi-campus activities and teaching.
- Other duties as assigned.
