#### **SCOPE OF WORK:**

Forestry Aide (Fuels) is a Temporary position for Menominee Tribal Enterprises. Primary responsibilities of the position are to assist the Fuels Crew with fuels management activities, such as: prescribed burn preparation, project monitoring, mechanical hazard fuels reduction projects, and if qualified prescribed burn implementation.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

##### **Must have the knowledge, skills, and ability to perform the following:**

1. Perform project work such as fuel inventory and hazard fuels reduction projects.
  2. Utilize a variety of specialized tools, machinery equipment and techniques while implementing fuels projects (hazard fuels reduction and if qualified prescribed fire).
  3. Chops brush, falls small trees, moves and piles brush using various hand tools such as axes, shovels, pulaskis, McLeods, power tools, and chainsaws.
  4. Cleans, reconditions, and stores tools and equipment.
  5. Perform project work such as fuel inventory and hazard fuels reduction projects.
  6. Ensure self and others' welfare and safety in all aspects of project implementation.
  7. Participates in fuels management reviews, proficiency checks and drills, safety sessions, and after action reviews.
  8. Be involved in teaching and mentoring new Fuels Crew members.
  9. Perform duties under stressful and adverse operating conditions, such as; long work hours, heavy workloads.
  10. Ability to verbally communicate with other crew members in a team environment.
- Perform other duties as assigned by supervisor.

#### **WORKING CONDITIONS:**

Employee must be able to work outdoors independently for extended periods in adverse terrain and weather conditions throughout the year. Work requires regular and protracted periods of strenuous physical exertion including prolonged standing, frequent bending, stooping, walking cross country, climbing, etc., over uneven ground and steep terrain. The hazardous nature of the work requires conformance to safety requirements & the use of safety equipment and clothing. The work is typically performed in a forest setting. Must be able to lift up to 50 lbs. Must wear all appropriate safety apparel and equipment and comply with all safety policies and practices of MTE.
